- A logically sound opening — delivered via PowerPoint — that begins to lose emotional connection with the jury in the first five minutes.
- A sustained objection that interrupts rhythm and quietly fractures authority.

These inflection points are nearly impossible to self-correct in real time without practice and trained external observation. And once momentum shifts, it compounds.
